Ohio law requires that all contributors must provide their name and address regardless of contribution amount and the name of their employer if the contribution is for more than \$100. If the contributor is self-employed, the business name and occupation of the contributor must be reported. Ohio law bars the award of unbid contracts to certain campaign contributors who have given in excess of specified amounts to the candidate who will have the authority to award the public contract. DeWine Husted for Ohio does not intend to solicit employees of the office of Attorney General, Secretary of State, Governor, Lieutenant Governor or state departments.
